



Invasive Meningococcal Disease: 2018

Los Angeles County Epidemiology Report

June 29, 2018



One new case of invasive meningococcal disease (IMD) was reported this week in LAC. A total of 8 IMD cases have been documented in 2018 in LAC, including one fatality (Table 1). Four cases are serogroup C, 2 are serogroup B, 1 is serogroup Y, and the most recent case is pending a serogroup result. All 4 serogroup C cases have been determined by molecular analysis to have been infected with the outbreak strain. None have identified social linkages with the MSM community. The regional outbreak due to serogroup C, occurring primarily among MSM*, has been ongoing since March 2016, and includes 40 cases from jurisdictions throughout southern California. This report is the last weekly update until new information related to the outbreak arises. Providers should continue to offer meningococcal vaccination for certain high risk groups (see box). Providers should implement evidence-based practices to ensure completion of the 2-dose vaccination schedule for all HIV-infected persons.

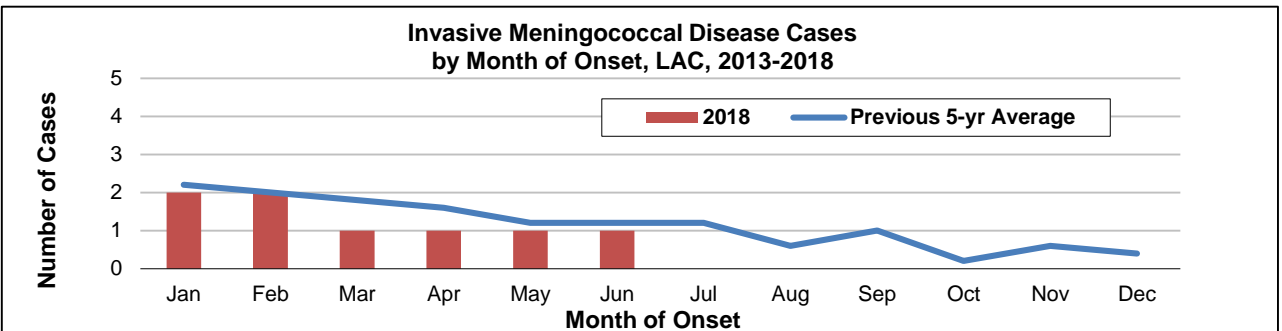

Recommendations and Resources

LACDPH recommends meningococcal conjugate vaccine be offered to:

- All MSM, regardless of HIV status;
- All HIV-infected persons.

Routine vaccination is recommended for all persons 11-12 years of age, with a booster dose at 16 years.
