

Reopening Protocol for Warehousing, Manufacturing and Logistic Establishments: Appendix C

Recent Updates: (Changes highlighted yellow) 2/5/21:

- Employee break rooms must have posted occupancy limits and must be reconfigured to enable 6-foot physical distancing between employees.
- Employees must wear a face covering at all times except when alone in a closed office or when eating or drinking during breaks.

The County of Los Angeles Department of Public Health is adopting a staged approach supported by science and public health expertise, to allow certain retail businesses to safely reoper. The teopering protocols below are specific to warehousing businesses that support Lower-Risk Retail Businesses that are permitted to reopen by the County Health Officer Order issue on May 13, 2020. In addition to the longitions required of these specific sectors by the State Public Health Officer these types of businesses must also be in compliance with the conditions laid out in the Checklist for Warehousing, Manufacturing and Logistic Establishments provided below.

A. WORKPLACE POLICIES AND PRACTICES TO PROTECT EMPLOYEE HEALTH (CHECK ALL THAT APPLY TO THE FACILITY)

Everyone who can carry out their work duties from home has been directed to do so.
Vulnerable staff (those above age 65, those with chronic health conditions) are assigned work that can be done from home whenever possible.
Work processes are reconfigured to the extent possible to increase opportunities for employees work from home.
Alternate, staggered or shift schedules have been instituted to maximize physical distancing.
All employees have been told not to come to work if sick, or if they are expose to preson who has COVID-19. Employees understand to follow DPH guidance for self-isolation and queran new applicable. Workplace leave policies have been reviewed and modified to ensure that employees are not penalized when they stay home due to illness.
Workers are provided information on employer or government-sponsored leave benefits the employee may be entitled to receive that would make it financially easier to stay at home. See additional information on government <u>programs</u> supporting sick leave and worker's compensation or COVID-19, including employee's sick leave rights under the <u>Families First Coronavirus Response Act</u> and employee's rights to workers' compensation benefits and presumption of the work-relatedness of COVID-19 pursuant to the <u>Governor's Executive Order N-62-20</u> .
<u>Employee screenings</u> are conducted before employee may enter the workspace. Checks must include a check-in concerning cough, shortness of breath, difficulty breathing and fever or chills and if the employee is currently under isolation or quarantine orders. These are sky on be done remotely or in person upon the employees' arrival. A temperature check should also be done at the worksite if feasible.
Upon being informed that one or more worker/practitioner, independent contractors and temporary workers test positive for, or has symptoms consist or which 2VID-19 (case), the employer has a plan in place to have the case(s) isolate themselves at home and require the immediate self-quarantine of all workers that had a workplace exposure to the case(s). The employer's plan should consider a protocol for all quarantined workers to have access to be tested for COVID-19 in order to determine whether there have been additional workplace exposures, which may require additional COVID-19 control measures. See the public health guidance in responding to COVID-19 in the workplace.
In the event that 3 or more cases at cidentified within the workplace within a span of 14 days, the employer should report this cluster as the Department of Public Health at (888) 397-3993 or (213) 240-7821 or online at www.redcap.link/co.ide.port . If a cluster is identified at a worksite, the Department of Public Health will initiate a cluster response y nich includes providing infection control guidance and recommendations, technical support, and site-specific control measures. A public health case manager will be assigned to the cluster in estigation to help guide the facility response.
Employee who ave contact with others are offered, at no cost, an appropriate face covering that covers the nose appropriate. The covering must be worn by the employee at all times during the workday when in contact of tikely to come into contact with others. Employees who have been instructed by their medical provider that they should not wear a face covering must wear a face shield with a drape on the bottom case, to be in compliance with State directives, as long as their condition permits it. A drape that is form fitting under the chin is preferred. Masks with one-way valves must not be used. All employees must wear face coverings at all times except when working alone in private offices with closed doors or when eating or drinking. The exception made previously for employees working in cubicles with solid partitions exceeding the height of the employee while standing is overridden.
To ensure that masks are worn consistently and correctly, employees are discouraged from eating or drinking except during their breaks when they are able to safely remove their masks and physically distance

from others. At all times when eating or drinking, employees must maintain at least a six-foot distance from others. When eating or drinking, it is preferred to do so outdoors and away from others, if possible. Eating



or drinking at a cubicle or workstation is preferred to eating in a breakroom if eating in a cubicle or workstation provides greater distance from and barriers between workers.

- Occupancy is reduced and space between employees is maximized in any room or area used employees for meals and/or breaks. This has been achieved by:
 - o Posting a maximum occupancy that is consistent with enabling a distance of at least six feet between individuals in rooms or areas used for breaks; and
 - Staggering break or mealtimes to reduce occupancy in rooms or areas used for meals and be and
 - Placing tables six feet apart and assuring six feet between seats, removing or ten

reduce occupancy, placing markings on floors to assure distancing, and arranging scating in a way that minimizes face-to-face contact. Use of partitions is encouraged to fart, or prever, spread but should not be considered a substitute for reducing occupancy and maintaining, hysical distancing.			
Employees are instructed to wash or replace their face coverings daily.			
To the extent feasible, entry is limited to employees of the site. When other artiesplay a role in the world flow, they are instructed to wear face coverings and to comply with sympton checks and physical distancing.			
All workstations/areas are separated by at least six feet.			
Break rooms, restrooms and other common areas are disinfected in urly, on the following schedule:

В.	MEASURES TO ENSURE PHYSICAL DISTANCING
	The number of employees on site at any time has been reduced as needed to permit compliance with physical distancing and infection control requirements.
	If employees must line up for symptom checks before entering, barriers or markings at 6-foot intervals have been placed to permit physical distancing.
	Separate entry and exit points have been identified to minimize crowding, allow for monitoring of occupancy and leave room for symptom checks as employees enter. If the facility has only one employee entrance, we have left an adequate gap between shifts to avoid entryway crowding
	Employees have been instructed to maintain at least a 6-foot distance from each other in a areas of the workplace.
	If applicable, elevator capacity is limited to 4 individuals or fewer at a time for any envator that does not allow for 6-foot physical distance between riders. All riders are required to wear cloth face coverings. Consider elevator sizes, number of building floors, and daily number of employees and visitors to establish physical distancing guidelines appropriate for elevator riders.
	If applicable, stairwells have been opened for "up" or "down" traffic with incressed cleaning of stairwells.
	Furniture placement in offices, public seating areas and other convarehouse or production areas is reconfigured to support physical distancing.
	If applicable, aisles on the warehouse or shop floor are designated as one-way to support physical distancing.
	Common areas are configured to limit employee gatherings a ensure physical distancing of at least 6 feet.
	Occupancy in employee restrooms, break rooms and other common areas is limited to permit physical distancing.
	Transfer aiding materials, such as shelving or build. boards, is installed to avert the need for person-to-person hand-offs.
	Work flow is reviewed and changes made if needed to permit physical distancing during pickups and deliveries.
C.	MEASURES FOR INFECTION CONTROL
	The HVAC system is in 3000 working order; to the maximum extent possible, ventilation has been increased. Consider in talking portable high-efficiency air cleaners, upgrading the building's air filters to the highest efficiency possible and making other modifications to increase the quantity of outside air and ventilation in all working areas. Hands-free equipment is installed wherever feasible (including restrooms) to reduce risk of contamination.
	Visitors are bring at the establishment are reminded to wear a face covering at all times (except while eating or drinking a applicable) while in the establishment or on the grounds of the establishment. Only individuals and average instructed not to wear a face covering by their medical provider are exempt from wearing one to support the safety of your employees and other visitors, a face covering should be made available assistors who arrive without them

currently under isolation or quarantine orders. These checks can be done in person or through alternative methods such as on-line check in systems or through <u>signage</u> posted at the entrance to the facility stating that visitors with these symptoms should not enter the premises.

Synctom checks are conducted before visitors may enter the facility. Checks must include a check-in concerning cough, shortness of breath, difficulty breathing, fever or chills, and whether the individual is
