From Certification to Inspiration: How One Pantry Site in Lancaster Paved the Way for New Partners

Antelope Valley is home to many families seeking to spend quality time together without leaving the community, while also wanting greater access to services and equitable opportunities. The City of Lancaster, part of the Antelope Valley, understood the need for access to services for its community members. This need inspired the idea of Community Impact Homes, which are homes strategically selected throughout the community to provide services within walking distance in that neighborhood. The services provided vary from home to home and are based on community feedback.

Guyman Community Pantry (Guyman) is one of the star Community Impact Homes. By utilizing a client needs survey, not only did it determine the types of services community members wanted to see provided, but also ensured that the community had a voice in shaping the offerings and addressed their unique needs. The drive to continue working to meet the needs of the community led Guyman to become part of the Nutrition Pantry Program (NPP).

Community Assets

Guyman has a strong partnership with Antelope Valley Partners for Health (AVPH). AVPH aims to improve the lives of people in the Antelope Valley by leveraging community strengths and resources, initiating a coordinated effort with food providers, known as the AV Food Access Network (AVFAN) to address local health policies that promote equitable food access for all. AVPH has worked in tandem with Guyman and other AVFAN partners to implement the Nutrition Pantry Program (NPP).

One focus area of the NPP is Community Connections. AVPH and Guyman utilized the insights from the client needs survey which established the outreach to other service providers in the area. The community connections that were secured by Guyman are: CalFresh enrollments, vaccinations for children, donations of school supplies, after-school support, and a community garden.

Thanks to the community and their support for the services provided, successful implementation of the NPP led Guyman to achieve Gold Certification from Leah's Pantry, the organization overseeing the national NPP network. In that achievement, Guyman also received acknowledgement by the City of Lancaster for its commitment to community wellness.

Collaborative Action

The Los Angeles County Department of Public Health partnered with AVPH to implement the NPP through the CalFresh Healthy Living program. The NPP supports policy, systems, and environmental changes at food pantry sites that lead to client-centered, health-focused distributions. The NPP strives to enhance each implementing site's processes by providing resources, technical assistance and sharing best practices.

The NPP serves as a guide to food pantries to develop site-specific changes to become a client-centered, health-focused distribution through six focus areas that include pantry environment, nutrition education, inventory, cultural and dietary accommodations, community connections, and pantry policies & procedures. Through the NPP, AVPH has engaged with various pantry partner sites, fostering communication and collaboration that have led to successful certifications and showcasing community achievement. With Guyman's Gold certification, the City of Lancaster is inspired to encourage the certification of any new pantry sites, reinforcing the importance of connecting with the community to sustain ongoing success.

Sustaining Success

With a strong focus on community connections at Guyman, there continues to be new collaborations to provide more access to fresh and healthy options and continue the work of the other NPP focus areas. Guyman has inspired another community partner, New Horizon 4 Life, to start a food pantry site in an area of Lancaster where residents would like to access fresh produce while strengthening community support.

New Horizon 4 Life reached out to the City of Lancaster to secure space at one of their Community Impact Homes for a new food pantry site. This collaboration would further the City's vision of ensuring that essential services are accessible and within walking distance for residents, strengthening community support and engagement in the neighborhood.

By continuing communication of the NPP progress through the AV Food Access Network and receiving community member feedback, there will be ongoing support for local food access initiatives and potential for new collaborators in the AV.
