### **Nutrition Access LA History**

#### • 2008

- United States Department of Agriculture (USDA) directive for agencies receiving SNAP-Ed funding to create a collaborative with federally food assistance programs.
  - Aim: To increase collaboration and partnership among SNAP-Ed and federal food agencies who serve the same target audience.
  - In California, referred to as "County Nutrition Action Plan" (CNAP)
- DPH convened introduction meeting with stakeholders in LA County on how to coordinate CNAP efforts.



### **History Cont.**

- 2009-2014
  - 16 partners joined LA County's CNAP
  - Established a rapport with food assistance and government agencies
  - Integrated 2 California Department of Public Health (CDPH) campaigns into WIC nutrition education classes
    - Not My Kids shared with 135,000 WIC participants
    - Be Better shared 134,000 WIC participants
  - Created WIC + CalFresh, Better Together flyer; reached
     10,000+ community members
  - Promoted food assistance program information on DPH's Nutrition website.



## Facebook Live Chats (2018)



- Partners: Office of Immigrant Affairs, WIC, DPSS, and a nutritionist influencer
- Discussed how CalFresh and WIC can support healthy eating



- Partners: No Kid Hungry and a Registered Dietitian influencer
- Discussed importance of children eating breakfast, including School Breakfast Program.



# **Nutrition Access LA Organizational Structure** (2018-2022)

- Formed a steering committee
- Added a co-chair position (non-County entity)
  - Expanded focus to support more policy efforts
  - Co-chair led Policy Subcommittee
- Changed the name from CNAP to Nutrition Access LA
- Expanded membership to CalFresh Healthy Living (CFHL)
  partners to ensure collaboration between CFHL and
  federally funded food assistance programs.



# Food Equity Roundtable (2021)



- County of Los Angeles Board of Supervisors initiated a motion to establish the Food Equity Roundtable.
- Funded by LA-area philanthropic partners
- Co-chaired by Chief Sustainability Office and Annenberg Foundation
- Developed a strategic action plan to end food and nutrition security
- Roundtable formed a Policy & Advocacy Subcommittee and later merged efforts with NALA's Policy Subcommittee



# Office of Food Equity (2023-Present)

- Based on the Roundtable's recommendation to advance the implementation of the action plan.
- Represents LA County's commitment toward creating comprehensive approaches and developing solutions to address food and nutrition security.
- NALA will support the Office of Food Equity in policy and advocacy efforts.

#### Mission

 To ensure that people who are vulnerable in Los Angeles County have sufficient, nutritious, and affordable food through policy changes and organizational/institutional capacity building.

#### Vision

A food and nutrition secure Los Angeles County.



#### **Nutrition Access LA Goals**

- Educate community members on how to navigate nutrition assistance programs and other nutrition and food resources.
- Inform partner organizations on food and nutrition insecurity, food assistance programs, food and nutrition policy, and other nutrition and food resources.
- Advance food and nutrition policy related to nutrition insecurity, food assistance programs and other nutrition and food resources.
